Raffle Name

- 1. Opening date of ticket sales: 04/02/25
- 2. Closing date of ticket sales: 06/10/25
- 3. No entries will be accepted after 10.00am AEDT on the closing date 06/10/25.

Draw

- 1. The Major Raffle will be drawn at 2:00pm AEDT on 08/10/25 at: Melbourne Cricket Ground Shane Warne Stand, Brunton Avenue East Melbourne VIC 3002
- 2. A ticket number will be drawn at random. The prize will be allocated to the first ticket number drawn.
- 3. The winner will be notified via email and phone, with the winner's details to be displayed at http://www.melbournefc.com.au from 11.00am AEDT on 10/10/25 if the prize has been claimed.
- 4. The results of the draw will be final, and binding and no correspondence will be entered into in relation to the results of the draw.
- 5. The Promoter must distribute the prizes to the winners within 28 days of the draw.

Tickets

- 1. A maximum number of 2,500 tickets are offered for sale in the Raffle.

Prize Schedule

Victoria: If the Prize winner resides in Victoria - Gold Bullion

The gold is purchased on the day of the draw to the value of the prize (AUD \$30,000), at the price of gold on that day. The club will work with the winner to assist in setting up an account with ABC Bullion (or similar as nominated by the Promoter) to store gold winnings. The winner will have the option to store their gold with ABC Bullion (or similar as nominated by the Promoter), sell the gold, or convert the storage bullion to physical bars. The buy-back price is likely to be different from the sell price of gold. Selling and administrative fees are incurred by the winner on the sale of their gold bullion. The winner has 12 months from the date of the draw in which to claim their prize. If the prize is still unclaimed after 12 months, it will be sold, and proceeds (after deducting reasonable costs of sale) paid to the Treasurer for payments into the Consolidated Fund.
