

2024 Melbourne Demon Draw Terms & Conditions

Raffle Name

1. 2024 Melbourne Demon Draw (the 'Raffle').

Promoter/Recipient

Promotion Period

1. Opening date of ticket sales: 08/02/24
2. Closing date of ticket sales: 04/10/24
3. No entries will be accepted after 10.00am AEDT on the closing date 04/10/24.

Draw

1. The Major Raffle will be drawn at 2:00pm AEDT on 08/10/24 at:

Shane Warne Stand, Brunton Avenue
East Melbourne VIC 3002
2. A ticket number will be drawn at random. The prize will be allocated to the first ticket number drawn.
3. The winner will be notified via email and phone, with the winner's details to be displayed at <http://www.melbournefc.com.au> from 11.00am AEDT on 09/10/24 if prize has been claimed.
4. The results of the draw will be final, and binding and no correspondence will be entered into in relation to the results of the draw.
5. The Promoter must distribute the prizes to the winners within 28 days of the draw.

Tickets

1. A maximum number of 2,500 tickets are offered for sale in the Raffle.
2. Price per ticket: \$200.00
3. Price per set of 3 tickets: \$500.00
4. Price per set of 6 tickets: \$1,000.00
5. Price per set of 10 tickets: \$1,650.00

Entry

1. Entry is open to members of the public only in VIC and NSW. Participants do not need to be a Club member or supporter to purchase a Raffle ticket.
2. Employees, directors or officers of the Promoter, any companies or agencies associated with this competition, or their immediate families, are ineligible to enter.
3. Members of the public under 18 years old are ineligible to enter.
4. Participants who purchase a ticket must provide and or confirm contact details during the purchase process in full by providing their name, address, telephone number and email (if applicable) for their entry to be eligible. Participants may purchase as many tickets as they like.

Prizes

Prize Schedule

<p>Victoria: If the Prize winner resides in Victoria – Gold Bullion</p> <p>The gold is purchased on the day of the draw to the value of the prize (AUD \$30,000), at the price of gold on that day. The club will work with the winner to assist in setting up an account with ABC Bullion (or similar as nominated by the Promoter) to store gold winnings. The winner will have the option to store their gold with ABC Bullion (or similar as nominated by the Promoter), sell the gold, or convert the storage bullion to physical bars. The buy-back price is likely to be different to the sell price of gold. Selling and administrative fees are incurred by the winner on sale of their gold bullion. The Winner has 12 months from the date of the draw in which to claim their prize.
